DESCRIPTION: This course was designed to provide counseling and peer support to personnel who have been involved in a police shooting incident / critical incident. This course will address topics such as survival, isolation, depression, danger signs, and myth vs. reality of stress, perceptual distortions and moment of resolve.

INSTRUCTORS: Nancy Bohl, Pd. D. and J.D. Harris, Psy. D. of the Counseling Team

PREREQUISITE: Been involved in a police shooting / critical incident.

PRESENTATION DATES & HOURS: This is a 16-hour course that will be presented on the above stated dates. **Arrive no later than 1600 hours on the first day for check-in.** *Dinner will be served at 1800hrs, followed by a social hour the first night.. Room check out will be Wednesday the last day of the course by **noon**, or an additional departure fee will be billed to agency.*

LOCATION: This course will be presented at UCLA Conference Center in Lake Arrowhead.

CERTIFICATION & FEES: POST Plan IV ***POST will only reimburse up to \$124.00 per day, which includes lodging and meals**.* Total course fee: \$584.00. Includes; tuition, lodging and meals. Send payment in advance (payable in a single check) to the Riverside Sheriff's Department, 16791 Davis Avenue, Riverside, California, 92518 (**Attn: Account and Finance**).

***If payment has not been confirmed immediately after enrolling in class, the student will be dropped from the list. Please reference the course title on the check.*

REQUIRED EQUIPMENT: **Copy of your RCC application confirmation.**

COURSE ENROLLMENT: This course is limited to 20 students and reservations will be made on a first come, first serve basis. CANCELLATION POLICY: This course is sponsored by; the Riverside County Sheriff's Department, at the UCLA Conference Center in Lake Arrowhead. Cancellations made anywhere from one month to one week prior to class are subject to UCLA Conference Center **cancellation charges** of \$175 per person / per night. If cancellations are made less than a week before class or if the student(s) are a no-show, the agency will be charged the entire course fee:

LODGING: All meals and lodging are included in the course fee and based on double occupancy. The room and meal portion of the course fee is \$155 per day. Rooms are two bedrooms/two baths and three full meals a day are provided in the dining room.

If single occupancy is requested, there is an additional fee of \$60 per person. A fee of \$125.00 will be charged per additional person, per night (for example, bringing a spouse).

Location / Directions

The UCLA Conference Center (909-337-2478) is only 90 mostly freeway miles from Los Angeles (two hours) and one and a half hours from Orange County. In fact, we're less than two hours from most Southern California areas. The drive up the mountain is again mostly freeway and mostly spectacular! [See map.](#)

Please Note: There is a short detour on Highway 18 from the Crestline turn-off. Details are included in the directions below. This detour through Crestline will add approximately 5 minutes to your trip.

DIRECTIONS from Southern California

To reach the intersection of I-10 and I-215 in San Bernardino:

- from Los Angeles area and north, take I-10 East
- from Long Beach area, take Hwy 91 East
- from Orange County, take Hwy 91 East
- from San Diego, take I-15, then I-215 North

- go NORTH on I-215 for 6 miles to fork
- bear RIGHT on Hwy 30; exit at Hwy 18 (Waterman Ave.)
- go LEFT on Hwy 18 for about 12 miles to the Crestline turn-off.
- go RIGHT at the Crestline turn-off. (There are detour signs here, and you can only go to the right).
- IMPORTANT: TURN RIGHT AT FIRST STOP SIGN at top of Crestline turn-off onto Crest Forest Drive
- Crest Forest Drive will drop you off right back onto Highway 18
- Stay on Highway 18 to the Lake Arrowhead turn-off
- go LEFT to Lake Arrowhead on Hwy 173 for 2 miles to 4-way stop
- go RIGHT on Hwy 173 for 4 3/4 miles to Willow Creek Road on left
- go LEFT on Willow Creek Road 1/2 mile to entrance on right

DIRECTIONS from Ontario Airport

From the intersection of I-10 and I-215:

- go NORTH on I-215 for 6 miles to fork
- bear RIGHT on Hwy 30; exit at Hwy 18 (Waterman Ave.)
- go LEFT on Hwy 18 for about 12 miles to the Crestline turn-off.
- Turn right at the Crestline turn-off. (There are detour signs here and you can only go to the right).
- IMPORTANT: TURN RIGHT AT FIRST STOP SIGN at top of Crestline turn-off onto Crest Forest Drive
- Crest Forest Drive will drop you off right back onto Highway 18
- Stay on Highway 18 to the Lake Arrowhead turn-off
- go LEFT to Lake Arrowhead on Hwy 173 for 2 miles to 4-way stop
- go RIGHT on Hwy 173 for 4 3/4 miles to Willow Creek Road on left
- go LEFT on Willow Creek Road 1/2 mile to entrance on right
